A Message from the Executive Director



Dear Friends,

In 2017 Prairie State Legal Services celebrated 40 years as a nonprofit civil legal aid organization. While pondering what to say in this message, I looked back at a message written by Joe Dailing, my predecessor and Prairie State's founding executive director, upon celebrating Prairie State's 20th anniversary in 1997. I am amazed by the parallels from that time to the present day and how history appears to repeat itself.

A few examples:

In 1987, Joe Dailing wrote: *"The last 20 years, however, have been eventful times for Prairie State as an organization. In 1981, President Reagan came very close to eliminating federal funding for the Legal Services Corporation (which provides the majority of Prairie State's funding), but we survived. In 1995, Congress almost eliminated federal funding for the Legal Services Corporation again, but we survived."*

President Trump proposed the same action in 2017. Just as in 1981 and 1995, we survived. A strong coalition, which included the Supreme Courts of every state in the nation and the chief counsels of many of the biggest corporations in the nation, voiced their support for the important role of LSC in ensuring access to justice. As a result LSC funding was not eliminated and was in fact modestly increased.

"For the last 20 years, we have served more than 200,000 individual clients and an unknown number of their family members. We have educated clients about their rights under law through an active community legal education program."

Today, the number of clients served has increased to 531,000, and educating our clients and the communities we serve about their legal rights continues to be one of Prairie State's cornerstones. We have expanded our services to ensure that clients do not experience housing discrimination (Fair Housing Project), are able to keep their homes (Legal Help for Homeowners Project), and maintain their right to work and live their lives without the fear of past mistakes creating a hardship Ready to Work Project). In addition, we serve veterans in need through our partnership with the Illinois Armed Forces Legal Aid Network (IL-AFLAN).

"All of us, volunteers and staff, have worked very hard to make American society work better by trying to make real that phrase written above the United States Supreme Court, 'Equal Justice for All.' That work is worth celebrating. It is also worth celebrating that we accomplished this while working with some of the finest people who will ever cross our paths."

I too have the privilege of working with the finest people one could ever hope to encounter; the devoted staff of Prairie State (including many who were with us in 1997); the attorneys and others who generously donate their time and talent; and donors, funders, and community partners whose support helps make equal access to justice a reality. These people all share a commitment to achieving justice and fairness for our clients and Prairie State is stronger because of our combined efforts.

Although Prairie State has accomplished much, now is not the time to rest on our laurels. The events of 2017 demonstrated that we have far to go to achieve the more perfect union and justice envisioned by the U.S. Constitution. We at Prairie State are ready and eager for the challenge.

I am pleased to present Prairie State's 2017 Annual Report. We strive to be good stewards of the funds that support our organization and we are proud to share this snapshot of our work and highlight our many accomplishments.

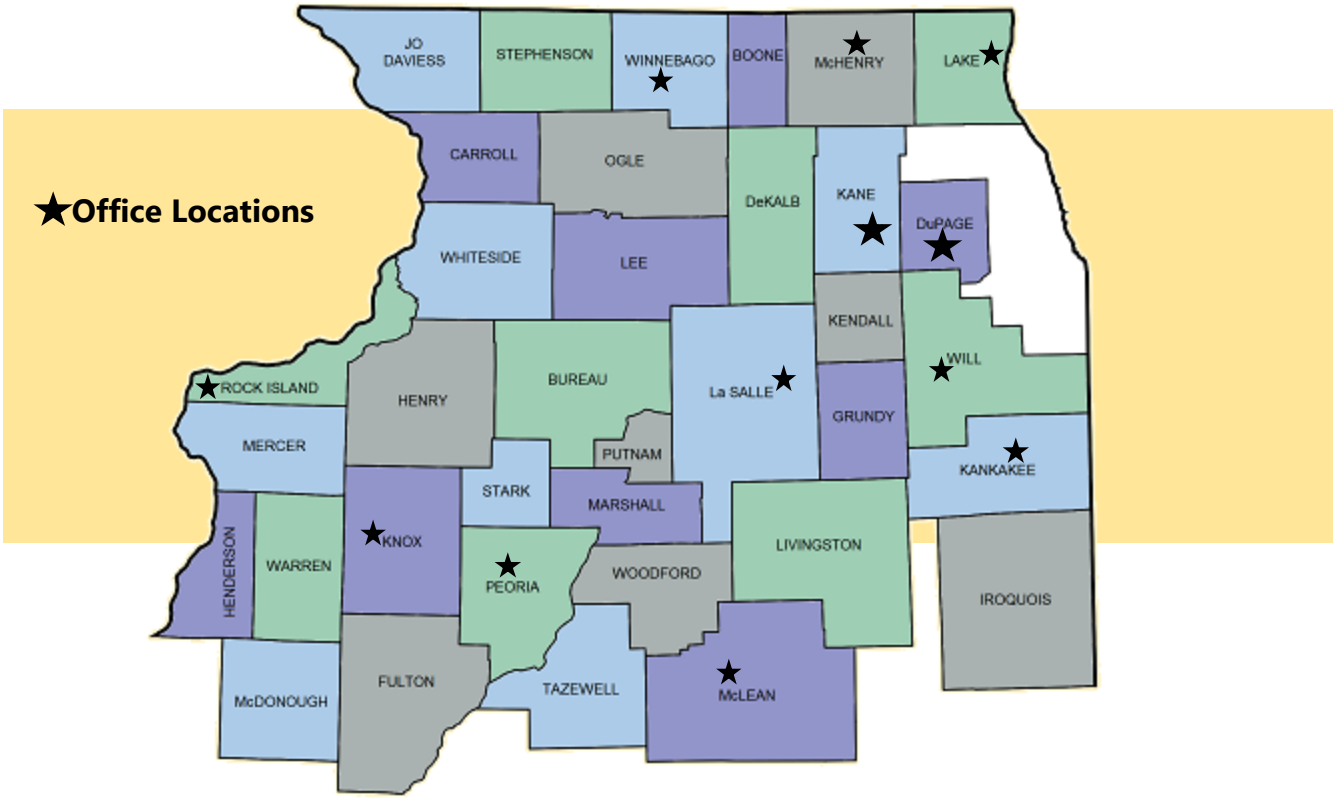
