# WHAT IS SOURCE OF INCOME DISCRIMINATION?

The Illinois Human Rights Act makes it illegal for housing providers to discriminate on the basis of your source of income.

# WHAT IS SOURCE OF INCOME?

The lawful way you support yourself and your family. Examples:

- Housing Choice Vouchers
- SSI/SSDI benefits
- Child support
- Retirement income
- TANF
- SNAP
- Inheritance

# WHAT DOES SOURCE OF INCOME DISCRIMINATION LOOK LIKE?

- A landlord says he does not accept Section 8 vouchers
- A landlord requires that tenants be employed
- A landlord does not cooperate with a housing authority's inspection
- A landlord runs a background check for voucher holders but not for other applicants
- A landlord requires a tenant with Social Security income to prove it is permanent income
- Other forms where tenants are treated differently because of their source of income

# WHAT IF A LANDLORD SAYS THERE IS A MINIMUM INCOME REQUIREMENT, OR THAT MY INCOME MUST BE THREE TIMES THE RENT?

This may be discrimination depending on the circumstances. Consult an attorney.

# WHAT CAN I DO IF I THINK I HAVE BEEN DISCRIMINATED AGAINST BASED ON MY SOURCE OF INCOME?

- Consider filing a complaint with the Illinois Department of Human Rights at illinois.gov/dhr.
- If you believe you were discriminated against because of your Housing Choice Voucher, also discuss this with your housing authority.
- Contact PSLS to speak with an attorney.
