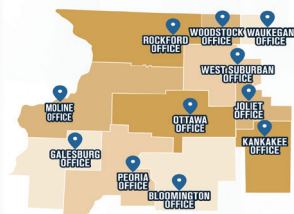


# WHAT IF I LIVE OUTSIDE OF PSL'S SERVICE AREA?
