WHAT IS IL-AFLAN?

The Illinois Armed Forces Legal Aid Network (IL-AFLAN) is a statewide legal aid hotline and referral network of legal services agencies seeking to meet the legal needs of Illinois veterans, service members and their families. Each network partner provides its own specific range of legal services to those who qualify.

PSLS is an IL-AFLAN partner that provides civil legal services at no charge for eligible persons.

WHO IS ELIGIBLE?

You may be eligible to apply for help if you, your spouse or a member of your household ever served in the military.

Applicants must:

- Be income-eligible
- NOT be dishonorably discharged
- Have an Illinois-based legal issue

CASES WE HANDLE

- Evictions, foreclosures, issues involving subsidized housing and utility shutoffs
- Government benefits
- Health care benefit denials
- Issues affecting personal safety, such as family violence
- Guardianships
- Criminal records relief

PSLS may be able to provide legal help or advice in many other areas of civil law. PSLS cannot assist with criminal or traffic matters.
