# 2022 Celebration of Pro Bono Week: A Reflection

Prairie State Legal Services (PSLS) was pleased to be a part of the National Celebration of Pro Bono, October 23-29. Pro Bono Week is a chance for us to celebrate and acknowledge the incredible work that more than 300 pro bono attorneys and volunteers have contributed to PSLS and its clients over the past year.

"We are so grateful for our ever-growing volunteer community," said Denise Conklin, Executive Director of PSLS. "My heartfelt thanks goes out to each volunteer who works in partnership with us to ensure access to justice in our communities."

The impact of our pro bono program is staggering. PSLS volunteers have worked on more than 1,500 cases and provided more than 5,100 volunteer hours of service through local offices, telephone counseling, and Pro Bono Unit projects. From family law, elder law, and evictions to expungement and sealing of criminal records, consumer law, and more, these clients likely would not have been served without our volunteers.

This year, we honored 13 members of the legal community who have provided exceptional service over the last year.



# Bill Spiro 2022 Distinguished Pro Bono Advocacy Award



Attorney William (Bill) Spiro began volunteering with Prairie State's telephone counseling service in April 2020 advising clients by phone on a wide variety of legal issues. From the outset of his pro bono service, Bill was ready and willing to advise any client with any legal issue, often taking the time and going the extra mile to speak

to a client in their native language using an interpreter. Cases in our hotline service must be placed with volunteers very quickly, and sometimes on short notice, but Bill never said no to helping a Prairie State client in need. In all his cases, he provides sound legal advice, a calm, honest, guiding hand, or even a pep talk to boost a client's confidence before going into court.

When the Pandemic Pro Bono Eviction Project launched in late 2020, Bill quickly jumped on board assisting clients with advice and negotiating agreements that allowed the client to stay in their home, or move out on a mutually agreed upon schedule, avoiding the potentially drastic effects of eviction. Overall, Bill has been a most reliable and productive volunteer, helping in more than 300 cases, with over 100 cases in the Pandemic Eviction Project.

# **Regional Billboard Campaign Seeks to Help Older Adults**

PSLS and AgeGuide Northeastern Illinois, a non-profit organization that works to address both the immediate and long-range needs of older adults, have partnered to launch an older adult public awareness campaign. The billboards, which promote PSLS' Older Adults Legal Assistance Helpline, will alert older adults on how to get legal help with Medicaid, Social Security, or SNAP, and will run over the next couple of months in DuPage, Kane, Kankakee, Kendall, Lake, McHenry, and Will Counties. In addition to billboards, digital placements will appear on Facebook, Google, and YouTube, and target residents living in Grundy and Kankakee Counties. # PSLS' Kankakee Office Receives United Way Community Impact Grant Funding

PSLS' Kankakee office recently received \$6,595 in Community Impact funding from the United Way of Kankakee and Iroquois Counties. The grant will support the costs of maintaining an office and providing holistic, no-cost legal services to nearly 600 low-income residents in Kankakee and Iroquois Counties. United Way's Community Impact grants are distributed annually to programs that fight for the health, education, and financial stability of individuals and families in Kankakee and Iroquois Counties.

Many of the PSLS Kankakee office referrals come from Harbor House and are related to issues of domestic violence. The office also receives referrals from the Ombudsman program to resolve nursing home issues and the Adult Protective Services to resolve elder abuse and exploitation issues. The office both sends and receives referrals to and from Catholic Charities, Kankakee County Community Services, and Options Center



for Independent Living to assist with public benefits, utilities/housing concerns, and other needs issues.

# Client Success: Making a Difference One Case at a Time

Lauren\*, a young high school dropout, had a minor criminal record and sought help at PSLS because she wanted to get her record sealed or expunged. After caring for her ailing grandmother, she became interested in healthcare work, but had one charge on her record that was holding her back from finding a job. Unfortunately, she was not yet eligible for sealing or expungement, but staff in our Peoria Office advised her to apply for a healthcare worker waiver.

First, staff investigated the details of Lauren's conviction. Then staff worked with her to write an accurate, but sympathetic explanation of her case for the Illinois Department of Public Health to show that she had changed since her conviction. PSLS staff also worked with Lauren to obtain written letters of support from members of her community who had witnessed her personal growth. Finally, PSLS staff helped Lauren draft a resume that she could use to find new job opportunities. Our efforts were successful, and Lauren obtained the healthcare worker waiver. Now she is working on her GED and will soon be eligible to seal her record.

During our first #GT campaign in 2016, we raised \$17,000. Only five years later, in 2020, we raised more than \$93,000. Last year we raised more than \$97,000.
